The Product is not designed for customers who:

- Have a short-term borrowing need (less than 5 years)
- Do not have a credible repayment strategy for interest only borrowing
- Are credit impaired borrowers
- Wish to let the property on a standard AST basis

### 4. Customers with characteristics of vulnerability

The Product is designed for those with a long term borrowing need, which may include some customers with characteristics of vulnerability or who will experience vulnerability over time.

Holiday Let mortgages should be considered carefully with the advice of a mortgage adviser and other lending options should be considered alongside where appropriate. In particular, the additional requirements and costs that accompany letting a property should be considered (maintenance, licensing, advertising etc.). Holiday Lets typically require more involvement than a long-term let so the customer should consider how the property will be managed.

We have designed our products and their associated lifecycle to take into account the needs, characteristics, and objectives of customers with characteristics of vulnerability. We will work closely with introducers to ensure their needs are met.

We have also tested the Product to assess whether it will meet the identified needs, characteristics, and objectives of the target market, including customers in the target market who have characteristics of vulnerability.

We have in place a framework to achieve good outcomes for vulnerable customers, which includes:

- Education and training for our staff to ensure they have the appropriate skills and experience to recognise and respond to the needs of vulnerable customers.
- A full-lifecycle customer service proposition to ensure the customer position is understood at outset, with flexible options for changing circumstances
- A bespoke approach that allows us to adapt our offering to our customers' needs
- Society-wide monitoring to ensure we continue to meet and respond to the needs of customers with characteristics of vulnerability.
